# **TERMS & CONDITIONS**





- 1. The "\$1,000,000 Bingo Draw" promotion ("Promotion") will take place from 13 November 2017 to 24 December 2017 (the "Promotion Period").
- 2. All existing Sands Rewards LifeStyle ("SRL") members and any visitors who sign up for an SRL membership at any Sands Rewards counter (each a "Member") in Marina Bay Sands Pte Ltd ("MBS") will be eligible to participate.

#### a. BINGO DRAWS

- 3. Bingo draws will be held on the dates and times set out in paragraph 5 below (each a "Bingo Draw"). Members may participate in a Bingo Draw by earning and redeeming Bingo cards (each a "Bingo Card") in accordance with these terms.
- 4.
