

Terms & Conditions

Sands Rewards LifeStyle Fortune Pursuit consists of 2 promotions:

I. Fortune Pursuit SWIPE & WIN KIOSK GAME (the "Kiosk Game")

- 1. The Kiosk Game Period is from 18 May to 13 June 2015 (27 days). Destination Points earned or Rewards Dollars spent from 27 April 2015 onwards shall be eligible for the Promotion, as further described below.
- 2. All registered Sands Rewards LifeStyle ("SRL") members of Marina Bay Sands Pte Ltd ("MBS") in good standing (each, a "Member") are eligible to participate.
- 3. In order to play the Kiosk Game, each member must swipe at any SRL kiosk located within MBS during the Kiosk Game Time on each day of the promotion. The timeframe for (i) earning eligible Destination Points or spending Rewards Dollars to play the Kiosk Game ("Point-Earning Period") and (ii) Kiosk Game Time are as follows:

7. Prizes in Destination Dollars will be credited into the member's SRL account within 48 hours from revealing their Prize.

8. By participating in the Promotion, Members agree to abide by the General Terms & Conditions set forth herein.

II. Fortune Pursuit WEEKLY LUCKY DRAWS

1. The promotion will take place from 27 April to 13 June 2015 (the "Promotion Period").

Entry Criteria

- 2. All new and existing SRL members of MBS in good standing are eligible to participate in Fortune Pursuit Lucky Draws. Lucky Draw Chances, as defined below, are subject to activation and automatically calculated with SRL Destination Points earned.
- Members earn one (1) Destination Point for every \$50 spent in SRL outlets. Destination Points earned during the Point-Earning Period automatically grants Members Lucky Draw chances (each, a "Chance"), as follow:

- 6. Each member is required to swipe his / her SRL membership card at any SRL kiosks within MBS during the Chance Activation Period to activate Lucky Draw Chance(s) containing his/her name and membership account details. The Lucky Draw details are as follow:

- 8. Five (5) random membership account numbers will be drawn at each Lucky Draw session (the "Selected Members').
- 9. Selected Members must approach the Promotion Area within twenty (20) minutes of announcement of the Draw result.
- 10. No redraw will be conducted if any Selected Member does not identified him/herself at the Promotion Area within twenty (20) minutes of announcement of the Draw results.

- 12. Upon identifying themselves at the Promotion Area, Selected Members will have a chance to win a prize through two random draw methods (e.g. wheel spin, punch box, mystery envelopes, pos, etc.), to be decided by MBS management.
 - a) The first round determines the base prize type and amount, Cash or Destination Dollars
 - b) The second round determines the Multiplier on the base Cash or Destination Dollars prize amount.
 - c) The final Cash or Destination Dollars prize amount won will be the product of the Multiplier and the base prize amount.
- 13. In this promotion, "Winner" is defined as a Selected Member who identifies him/herself at the Promotion Area within twenty (20) minutes of announcement of the draw and has their membership account number verified by an Event Official appointed by MBS. Failure to fulfill the requirement above will result in forfeiture of the prize claim and the Selected Member will not be considered as a Winner of the promotion "Fortune Pursuit Lucky Draw".
- 14. Each member can only be selected once during the promotion period to win in the **"Fortune Pursuit Lucky Draws"** on 23 May, 30 May and 6 June. - 15. All claimed lucky draw prizes (Destination Dollars) will be credited into member accounts within 48 hours.

General T&C:

- 16. All registered Sands Rewards LifeStyle members in good standing are eligible to participate. Only members in possession of membership cards with their names and photographs printed on the card will be able to participate in the promotion.
- 17. Selected Members whose SRL account will accumulate more than the maximum \$50,000 Destination Dollars must agree to sign and abide by the rules set forth in "Fortune Pursuit Lucky Draw" Winner's Letter.

- 20. The following parties are not eligible to participate in this event: (i) advertising agencies and affiliates of MBS; and (ii) employees of MBS and their immediate family members. It shall be the duty of employees of MBS to inform their immediate family members that they are not eligible to participate in the promotion. MBS reserves the right to refuse to issue a prize to a "winner" determined to be non-eligible.
- 21. By participating in the promotion, each member agrees that:
 - a. he/she has accepted these Terms and Conditions;
 - b. no claim relating to such losses or injuries (including special, indirect and consequential losses) shall be asserted against Marina Bay Sands Pte Ltd, its parent companies, affiliates, directors, officers, employees or agents from any and all losses, damages, rights, claims and actions of any kind resulting from the promotion or acceptance of any gift/prize/point, including without limitation, personal injuries, death and property damage;

 - d. in consideration of receiving any gift/prize/point from MBS, he/she grants MBS irrevocable and perpetual permission to use his/her name and other personal details, photographs, videotapes or any likeness of him/her for feedback, promotional, advertising, marketing and/or publicity purposes and to have his/her submitted name posted on MBS' websites, in print materials, radio broadcasts, displayed on MBS' Page, Twitter or any other social media pages and/or used by MBS for any purpose, at any time, without any fee or other form of compensation.

MBS reserves the right, at any time from time to time, temporarily or permanently, in whole or in part, to: (i) revise, alter or discontinue of the Promotion; and (ii) revise, alter or delete these Terms and Conditions, with or without prior notice. By participating in the promotion, Members are bound by the most updated version of the Terms and Conditions.
- 24. MBS reserves all rights in relation to the Promotion, including but not limited to the right to postpone, temporarily halt, or terminate this promotion, or adjust the prize structure, type and distribution at its sole and absolute discretion.
- 25. MBS has the right to final interpretation of these Terms and Conditions. The decision of Marina Bay Sands on all matters related to the promotion shall be final and binding. Members that fail to comply with any of the Terms and Conditions will have their prize(s) forfeited.
- 26. The promotion and all Terms and Conditions will be governed by Singapore law and participants agree to submit to the exclusive jurisdiction of the Singapore courts.
- 27. A person who is not party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or these Terms and Conditions.
- 28. The Chinese version of the Terms and Conditions are only provided for reference. In the event of conflict between the Chinese and English version of the Terms and Conditions, the English version shall prevail.
