

Terms and Conditions

Voucher Package (worth over S\$120) with S\$1,000 Spend at The Shoppes (with at least 1 receipt of any amount from participating Children's boutiques)

- 1. Marina Bay Sands Pte Ltd (the "**Organiser**" or "**MBS**") is the organiser of this Promotion, as described in paragraph 3 herein ("**Promotion**"). Terms and Conditions contained herein, including information on how to participate in the Promotion, apply to the Promotion. By participating in the Promotion, the participant agreed to accept these Terms and Conditions.
- 2. The Promotion shall take place from 10:00am on 22 April 2017 until 10:59pm on 19 May 2017 ("**Promotion Period**") and limited to 30 redemptions per week.
- 3. The Shopping Voucher may be redeemed at the redemption counter (**B2 Retail Concierge Counter near Skating Rink**).
- 4. During the Promotion Period, each participant meeting the following requirements each day may have the opportunity to redeem one (1) Voucher Package, for use at participating outlets and establishments within The Shoppes at Marina Bay Sands ("**The Shoppes**") as indicated on each Voucher Package:
 - a. Participant must show valid proof of identification (NRIC/Passport) for redemption purposes;
 - A minimum spend of S\$1,000 ("Spend") at participating stores located in The Shoppes at Marina Bay Sands, the ArtScience Museum, Theaters, Skating Rink, Sampan Ride, Banyan Tree Spa, Sands SkyPark and all participating restaurants & bars located in Marina Bay Sands;
 - c.  - e. The Voucher Package may only be redeemed on the date of the relevant receipts utilised for redemption. Receipts not dated on the day of purchase cannot be used for redemption at a later date or combined with receipt(s) of a later date;
 - f. The participant may not have previously redeemed the Voucher Package on the same day.
- 5. Subject to MBS' discretion to revise the contents of any Voucher Package, each Voucher Package ("Voucher Package") shall contain the following items:

Any disputes or issues in relation to the various components Voucher Package shall be settled between the participant and the relevant store without the involvement of MBS.

6. MBS reserves the right to disqualify any participant who does not meet the Terms and Conditions of the Promotion. These include entries submitted with invalid receipt(s) or incomplete or incorrect information. MBS is not responsible for the loss of opportunity to participate if for any reason whatsoever a participant is unable to comply with the Terms and Conditions of this Promotion.



- 7. MBS is neither responsible nor liable for any delayed, lost, stolen, incomplete, late or misdirected entries and submissions caused by any reason whatsoever.
- 8. The Voucher Package is only valid for use at participating stores within MBS as indicated on each individual voucher/ticket. Use of the Voucher Package shall be subject to any terms and conditions as printed on any vouchers or tickets within the Voucher Package.
- 9. The Voucher Package is non-transferrable, non-exchangeable, non-cashable and available in limited quantities. The Voucher Package or any part thereof may not be sold or used for any commercial purpose, including but not limited to any use for which the participant would be entitled to collect fees or receive any remuneration. MBS will be under no obligation to replace the Voucher Package or any part thereof, or to pay to any participant the value of the Voucher Package or any part thereof, if the Voucher Package or any part thereof is not utilized by any stipulated deadline(s).
- 10. At any time and without prior notice, MBS may amend these Terms and Conditions or terminate the Promotion and all participants shall be bound by such amendments or termination.
- 11. The Promotion is not open to employees of (a) tenants of The Shoppes or (b) Organizer. MBS reserves the right to refuse to allow a non-eligible party to redeem a Voucher Package.
- 12. By participating in the Promotion and/or accepting and/or using the Voucher Package or any part thereof, each participant:
 - a. agrees that no claim relating to such losses or injuries (including special, indirect and consequential losses) shall be asserted against MBS, its parent companies, affiliates, directors, officers, employees or agents from any and all losses, damages, rights, claims and actions of any kind resulting from the Promotion and acceptance of any gift and/or using the Voucher Package or any part thereof, including without limitation, personal injuries, death and property damage.
 - consents to MBS' use of their name(s), photograph(s), or any likeness of them for feedback, promotional, advertising, marketing and/or publicity purposes as MBS deems fit without any other fee or other form of compensation
 - c. consents to the collection, use and disclosure to third party service providers by MBS, of any personal data provided by a participant to MBS in conjunction with the Promotion, for such purposes as MBS deems reasonably necessary for the administration and management of the Promotion.

Each participant agrees to release, discharge, indemnify and hold harmless MBS and its agencies, affiliated companies, authorised partners, sub-contractors and their respective officers, directors, employees, agents from and against any claims, losses, liabilities, expenses, costs and damages arising from and in connection with participant's participation in this Promotion and the acceptance he Voucher Package or any part thereof. MBS makes no warranties, representations or guarantee either expressed or implied regarding any item purchased using the Voucher Package, including but not limited to any warranty of merchantability and fitness for a particular purpose.
- 14. In the event of any dispute, the decision of MBS is final and binding. Participants shall not commence any legal or other proceedings in any court or tribunal in any jurisdiction in respect of any such dispute.
- 15. A person who is not party to any agreement governed by these Terms and Conditions shall have no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of such agreement or these Terms and Conditions.
- 16. These Terms and Conditions shall be governed by Singapore law.
