

Terms & Conditions

- 1. The "**\$1,000,000 Bingo Draw**" promotion ("Promotion") which will take place from 12 November 2018 to 25 December 2018 (the "Promotion Period").
- 2. All existing Sands Rewards LifeStyle ("SRL") members and any visitors who have signed up for an SRL membership during the Promotion Period (each a "Member" and collectively, "Members) in Marina Bay Sands Pte Ltd ("MBS") are eligible to participate.
- 3. All SRL Members have to meet the spending criteria in conditions 4 during the period from 12:00am on 12 Nov to 4:00pm on each Bingo Draw ("Earning Period") to be eligible to participate in the Bingo Draws. No date or time extension for the redemption of winnings will be allowed.

a. BINGO DRAW

4. SRL Members are entitled to receive their first Bingo Card with a \$50 nett spend* at any Sands Rewards participating outlet in MBS during the Earning Period. Every subsequent Bingo Card (up to a maximum of eight (8) Bingo Cards can be obtained daily based on Member's SRL member card tier) will require a \$100 nett spend*. - 5. All SRL Members who make a successful referral of an eligible new SRL membership sign-up during the Earning Period will entitle both the referrer and referee one (1) Bingo Card each. Each referrer shall be entitled to a maximum of three (3) Bingo Cards. The referrer cannot refer themselves for this Promotion.
- 6. A maximum of 2,000 Bingo Cards will be given out for the referral programme.

- 8. SRL members with more than 10 bingo cards throughout the promotion will be entitled for a bingo card holder. Limited to one per member only and comes as first come first serve basis.

*The base prize pool for each draw is \$200,000.
