Terms & Conditions

- All existing SRL Members will be entitled to one (1) Bingo Card for every \$250 nett spend at any Sands Rewards participating outlet in MBS during the Earning Period. Nett spend refers to any spend, excluding goods and services tax and service charge, made by cash, NETS, Members' own credit card, debit card or redemption of Destination Dollars.
- MBS may, at its sole and absolute discretion, award additional Bonus Bingo Card(s) to selected SRL Members.

A. Bingo Draws

- SRL Members will need to redeem their Bingo Card(s) at designated redemption counters within the Bingo Cards Redemption Period in order to participate in the Bingo Draw on the respective draw dates:

- SRL Members can redeem up to two (2) Bingo Cards per day during the Bingo Cards Redemption Period as mentioned in paragraph 3.
- SRL Members will be able to redeem additional Bingo Cards based on the number of days they redeem Bingo Cards during each Redemption Period. For instance, SRL Member will be able to redeem two (2) Bingo Cards on the 1st and 2nd day each. *The base prize pool for each draw is \$100,000. If there is no winner for a particular draw, the prize money for that draw will be rolled over to the next draw, thus the total prize pool across the 5 draws will be \$2,000,000 if the multiplier is 4x.
