

TERMS & CONDITIONS

Sands Rewards LifeStyle Sands Blazing Race 2018 consists of 2 components, namely the Car Race Games and Bonus Lucky Draws:

- The 'Sands Blazing Race 2018' promotion ('Promotion') will take place from 13 August 2018 to 16 September 2018(the 'Promotion Period').
- All existing Sands Rewards LifeStyle ('SRL') members and any visitors who have signed up to become SRL members
 during the Promotion Period at any Sands Rewards counters (each, a Member' and collectively, Members') are eligible
 to participate.
- 3. All SRL members have to meet the spending criteria in conditions 5 and 16 during the period from 12:00am on 13 August 2018 to 4:15pm on each Draw Date ('Earning Period') to be eligible to participate in the Car Race Draws and Bonus Ludy Draws. No date or time extension for the redemption of winnings will be allowed.

CAR RACE GAMES

- Marina Bay Sands Pte Ltd ('MBS') will be setting up a Car Race Game venue at Level B1 Event Stage (above the Sampan Rides) (Event Area) at 5:00pm every Saturday and Sunday from 20 August 2018 to 16 September 2018.
- 5. For every \$10 nett' spend by an SRL Member at any Sands Rewards participating outlet in MBS during the Earning Period, the SRL Member will get one (1) chance to play the 'Car Pick' Game. Every subsequent chance to play (up to five (5) chances daily) the 'Car Pick' Game will require the Member to make another \$50 nett' spend. This is illustrated in the ability below:

*Nett spend refers to any spend excluding goods and services tax and service charge, made by cash, NETS, Members' own credit card, debit card or redemption of Destination Dollars.

- 6. Each SRL Member is required to swipe his/her SRL Membership card at any SRL kiosks located within MBS before proceeding to play the 'Car Pick' Game. When playing the 'Car Pick' Game, SRL Members get to pick three (3) out of twelve (12) available car numbers in any sequence of his/her choice. A kiosk slip (Race Ticket') with the picked car numbers and sequence will be printed. Details on the 'Car Pick' Games are set out in condition 8 below.
- 7. Each SRL Member is limited to a maximum of five (5) 'Car Pick' Games per day during the Promotion Period.
- The Race Ticket issued during the week, from Monday 12:00am up to Saturday 4:30pm, will be valid for the Car Race Draws taking place that weekend in the same week. To illustrate, if:
 - a. If the Race Ticket is issued on any day of the week of 27 August (including up to Saturday before 4.30 pm), the SRL Member will be eligible for the Car Race Draws taking place on that weekend, 1 September and 2 September.
 - If the Race Ticket is issued on a Saturday, 1 September after 4:30pm, the SRL Member will be eligible for the next day's Car Race Draw on Sunday, 2 September 2018.
 - c. If the Race Ticket is issued on a Sunday after 4:30pm, the SRL Member will be eligible for the Car Race Draws taking place at the following weekend, 8 September and 9 September.

- On each Car Race Draw Date, SRL Members will be able to view the winning '3' numbers in sequence for each
 Car Race Game on the TV screen located at the Event Area.
- 10. After announcement of the results to the Car Race Draw, SRL Members with numbers printed on his/her Race Ticket that matches the winning numbers for that day will need to swipe their SRL Membership cards at any SRL kiosks to redeem their winnings from 7:00pm on Sunday till next Monday, 11:59pm, failing which the SRL Member is considered to have forfeited the prize and will not be considered as a "Winner" of this Promotion. To illustrate, SRL members will need to redeem their winnings by 3 September, 11:59pm for Car Race Draws for 1 September and 2 September. The prizes to be won agree set util in Condition 14 helps.
- 11. Lost or stolen Race Tickets will not be re-issued or re-awarded.
- 12. No date or time extension for the redemption of winnings will be allowed.

* Destination Dollars will be credited into the winning SRL Members' accounts within 48 hours

14. Each set of car numbers and sequence in the Race Ticket can only be used to redeem the highest prize amount (In the event if the SRL Member has won the highest prize amount on both draw dates, he/she will only be entitled to 1 prize (e.g. \$188 instead of \$188 x 2). Prizes will be awarded in Destination Dollars as illustrated below.

II RONLISTLICKY DRAWS

- There will be one (1) Bonus Lucky Draw conducted the Event Area right after each Car Race Draw on every Saturday and Sunday from 25 August to 16 September 2018.
- 16. All members are entitled to one (1) initial free Lucky Draw chance (each, a 'Chance'). Every subsequent chance will require members to make \$50 nett' spend at any Sands Rewards Outlets in MBS, during the Earning Period.

 - ii. grants MBS permission to use his/her name and other personal details, photographs, videotapes or any likeness of him/her, for feedback, promotional, advertising, marketing and/or publicity purposes and to have his/her submitted name posted on MBS' websites, in print materials, radio broadcasts, displayed on MBS' Facebook Page, Twitter or any other social media pages and/or used by MBS.
- 31. SRL Members agree to comply with the Promotion's Terms & Conditions as well as the Terms & Conditions of the Sands Rewards LifeStyle Programme. Participation in and usage of certain prizes will be subject to terms and conditions in a prize letter which will be provided to the winners upon collection of the prize.
- 32. MBS may revise, alter or discontinue any part of the Promotion and may revise, alter or delete any Terms and Conditions at any time without prior notice. Any SRL Member found cheating will be disqualified from the Promotion and rendered ineligible for prizes. MBS reserves the right to disqualify any SRL Members from the Promotion for fraud, manipulation or other related issues, including providing false information (such as fake account(s), personas or photos) or for deliberately withholding information.
- 33. MBS reserves all rights in relation to the Promotion, including but not limited to the right to postpone, temporarily halt, or terminate the Promotion, draws or to adjust the prize structure, type and distribution in its sole and absolute discretion. MBS shall not be held liable for (i) any delay in performing or partial or total failure to perform any of their obligations to the winners under the Terms and Conditions applicable to the Promotions if such delay or failure is caused by circumstances beyond the reasonable control of MBS, its respective divisions, affiliates, authorised dealers/distributors, agents, suppliers of the prize(s), including without limitation delays, changes, disruptions, cancellations, diversions or substitutions howsoever caused including without limitation as a result of war, terrorist action or threatened terrorist action, strikes, hostilities, civil commotions, accidents, fire, flood or natural catastrophes. Each participating SRL Member agrees to release, discharge, and hold harmless MBS, its parent companies, affiliates, directors, officers, employees or agents from any and all claims including, without limitation, claims for slander, libel, defamation, violation of rights of privacy, publicity, personality, and/or civil rights, depiction in a false light, intentional or negligent infliction of emotional distress, copyright infringement, and/or any other tort and/or damages arising from or in any way relating to the submission of an entry, participation in the Promotions, and/or the use of the SRL Member's provided details and/or likeness in connection with the Promotions, or three of in all media now known or hereafter devised. By participating in the Promotions or accepting and/or using the prizes, the SRL Member agrees that MBS shall not be responsible, and that no claim relating to any losses or injuries (including special, indirect and consequential losses) shall be asserted against MBS, its parent companies, affiliates, directors, officers, employees or agents for any and all losses, damages, rights, claims and actions of any kind resulting from or related to the SRL Member's participation or inability to participate in the Promotion or the use, misuse or inability to use the prize or any portion thereof, including without limitation, personal injuries, death and property damage.

SRL Member shall indemnify MBS against any losses, claims, demands, liabilities, costs and expenses for personal injury or death, loss, damage to property, breach of any obligations, warranty or representation, intellectual property infringement claims, fines and penalties, which may be imposed on or which MBS may suffer or incur or which may be made, instituted or asserted against MBS arising out of or by reason of negligent acts, omissions, fraud, willful misconduct, or a breach of obligations, covenants, representations or warranties by the member in connection with this Promotion.
